

New Regulations to invite Cuban Citizens (Letter of Invitation)

From 2nd May 2007, there will be two different ways to apply for a Letter of Invitation, depending on the relationship between the Inviting person and the Invitee.

1) People that don't have direct relationship of consanguinity.

(All people that are not related or if related, that their relationship doesn't include Son, Parents, Grandparents or Grandchildren.)

THE INVITING PERSON MUST SEND TO US:

A) Completed Application Form (Appendix 1)

B) Photocopy of his/her passport

C) A letter signed by a Notary Public or Licensed Solicitor that includes: (See appendix 2)

- Personal details of the Inviting Person:
 - Full name
 - Passport number
 - Place and Date of Birth
 - Home Address
 - Occupation

- Personal details of the Invitee:
 - Full name (2 Surnames included)
 - Identity number. (Carné de Identidad)
 - Place and Date of Birth
 - Home address
 - Parent's names
 - Occupation

- General Information:
 - Reasons for the invitation;
 - Type of relationship (uncle-nephew, friends etc)
 - Type of Visit (Permanent / Temporary)
 - The commitment of the Inviting Person to take economical and legal responsibility for the Invited Person, so that the Invited person is not left unaided during their visit, and the commitment that the expenses of their return trip to Cuba are guaranteed by the Invitee.

The Notary will have to send a letter to de Consulate (Fax: 02 8399 1106) stating that he/she is authorized to legalise this kind of documents and must include specimen of signature and stamp used to legalise the before mentioned document. If this is not possible, the document will have to be legalised by the Department of Foreign Affairs and Trade.

2) People with relationship of direct-line consanguinity.

(Son, Parents, Grandparents, Grandsons)

THE INVITING PERSON MUST SEND TO US:

- A) **Completed Application form. (see appendix 1)**
- B) **Proof of Relationship. (If needed)**
- C) **Photocopy of his/her Passport**

COST OF THE PROCESS:

- The cost of the application for a Letter of Invitation is AUD 270.00. We only accept cash, Money Order or Bank cheques. Company or Personal cheques are not accepted. The cheques and Money Orders should be made to the order of:

"Consulate General of Cuba"

- The expenses incurred to obtain the Notary document and legalization of it, are not included in the amount previously mentioned and will be at the expense of the applicant.
- If the application is lodged via mail or courier it will attract an AUD40.00 administration fee.
